THE BOARD OF BUTTE COUNTY COMMISSIONERS CONVENED AT 6:00 P.M. on Tuesday, September 17, 2024. Commissioners present were Ager, Herman, Walton, Erk and Batterman.

Chair Ager called the meeting to order and led the group in the Pledge of Allegiance.

Motion by Walton, Second by Terry to approve the meeting agenda with no changes. Vote Unanimous. Motion Carried

Chair Ager called for a moment of silence/reflection.

Motion by Erk, Second by Herman, to approve the Consent Agenda Items with pulling of bills to be paid - item 3c which was added as item 3.5. Vote Unanimous. Motion Carried.

Motion by Erk, Second by Herman, to approve the bills for payment, 208197 and 208195. Vote Unanimous. Motion Carried.

Wyatt Leismeister, Butte/Lawrence 4H member, presented read Resolution 2023 SD 4-H Legislature HR6001. The first full week of October 2024 has been proclaimed National 4-H Week.

Beginning at 6:15 PM a public hearing was held to consider a special event retail (on-sale) liquor license. No one was present to speak for or against

Beginning at 6:17 PM a public hearing was held to consider the Five-Year County Highway And Bridge Improvement Plan for Butte County.

- Jason Hansen from Brosz Engineering provided an overview of the 2025-2029 Five-Year County Highway And Bridge Improvement Plan for Butte County.
- Travis Ismay asked about creating a maintenance plan/schedule.
- Highway Administrator Lori Johnston shared the current process for maintaining over 800 miles of county roads and how to contact the Highway Department regarding issues with roads.
- Dusta Ismay spoke about concerns regarding Wilson Cemetery Road and the Sheriff's ability to respond quickly during emergencies.
- Dale Simanton spoke about the condition of Stone Lake Road from the highway to the top of the hill and Hope Road from the highway to the Landfill. Mr. Simanton suggested taking more time on parts of the road.
- Kacy Jones asked if it was possible to focus on roads that need more attention at certain times of the year.
- Commissioner Ager asked about the status of the Gaver Road Bridge
- Commissioner Batterman asked about the financing of projects and how it affects the plan
- Dusta Ismay asked about the bridge on Gammon Road. Mr. Hansen explained this bridge is not part of the five-year plan as it has been closed. Discussion was held on other possible ways to ensure the bridge is not used and funding/requirements to remove the bridge at this time.

Motion by Herman, Second by Erk, to approve the 2025-2029 Five-Year County Highway And Bridge Improvement Plan for Butte County as presented. Vote Unanimous. Motion Carried.

Beginning at 6:44 PM opportunity for public comments was opened with Sue Broadhurst, and Dale Simanton providing comments regarding recent bridge repair, condition of roads, bids on skid steer, purchasing new vs used or renting of equipment, shopping local, and need for additional building.

Highway Administrator Lori Johnston provided an activity report including mowing, culvert repairs, blading, and mowing. Commissioner Ager passed on messages received regarding work on Sourdough and Jarvi Roads – residents are happy with the work.

Highway Administrator Lori Johnston provided information regarding the recently awarded BIG Grant.

Motion by Herman, Second by Erk, to approve and permit Chairman Ager and Auditor Capp to sign the 2025 Preliminary Engineering Bridge Improvement Grant Structure # 10-320-069. Vote Unanimous. Motion Carried.

States Attorney LeEllen McCartney provided an activity report stating they are busy and that Tim Barnaud has begun working as a part-time Deputy States Attorney while he finishes cases outside of Butte County. The office has also received an applicant for the additional Deputy States Attorney position.

Sheriff Lamphere provided a monthly activity report.

Discussion was held regarding water coolers/bottle fillers. There have been issues with the bottle filler in the lower level of the courthouse. Sheriff Lamphere stated the need for dispatch personnel to have water available. Additional discussion included the cost of new fillers vs preexisting machines and public access. Sheriff Lamphere to work with Auditor Capp regarding payment of renting coolers, State's Attorney, Admin building, and Register of Deeds are all paying for coolers in their respective offices. Questions were asked regarding purchasing vs renting equipment and the process for switching to new fillers.

Discussion was held regarding Cease-and-Desist order issued to Black Hills Bud. The order was issued due to foster children residing within 1000' of a medical marijuana facility. Since the order was issued, the children have been adopted resolving the violation. Other discussion included the security fence and proximity of children to the facility. The ordinance was reviewed specifically related to section involving proximity of children to facilities.

Motion by Herman, Second by Batterman to lift the Cease-and-Desist order issued to Black Hills Bud LLC. Roll Call Vote; Ager – Aye, Herman – Aye, Walton – Aye, Erk – Nay, Batterman – Aye. Motion Carried.

Motion by Walton, Second by Batterman to approve the 2025 Butte County Final Budget with changes from published Preliminary Budget below. Vote Unanimous. Motion Carried. Reasons for changes from provisional to final budgets were discussed.
