- Capp: Reminder of DANR meeting Thursday, November 17, 6:30 8:00 PM.

Beginning at 1:15 PM the following citizens appeared during the Public Comment Session:

- Katie Hoffman asked three questions of the commissioners including past recount process, potential of more evening meetings to accommodate public attendance, and consideration of budget when approving wage adjustments.
- Landowner Mike Bennet talked about issues with a neighbor and his options for taking
 action either thru the county or city. The property in question has one property on
 county side and other in the three-mile city limit. Commissioners suggested DANR
 may need to address HAZMAT issues and or bring civil action.

1:30 P.M. A Public Hearing for the first reading of 2022-02 Subdivision Ordinance was held at as scheduled.

- States Attorney LeEllen McCartney gave history and timing on original ordinance and changes in current version. SA McCartney shared information on the working group that developed the draft that was sent to Commission and planning board. Per Irrigation district there needs to be more guidance on irrigation requirements and language regarding FAA requirements (Airport Authority) will need to be added.
- Commissioners discussed the changes and asked representatives of the planning board and SA McCartney questions such as Purpose, Wastewater Ordinance, subdividing of

lots less than four, ingress and egress requirements, additional definitions needed, public notice requirements and enforcement.

- Public Comment was taken to discuss the Butte County Subdivision Ordinance
 - Paula Walker Register of Deeds asked who checks on mortgage holders (pg5
 1.b), said some verbiage related to the ROD office needs to be cleaned up, and asked about acreage requirements.
 - Alan Turbville asked about the definition of subdivision why was minor subdivision removed, final approval requirements restrictions on when information will be available on Page 14 1a, Page 18 – system development wording needs to be tweaked.
 - o Travis Ismay suggested it be sent back for further review based on comments.
 - Chad Erk mentioned that he received calls from members of the planning board to send back to the board for additional edits.
 - Laurel Allen suggested sending back to the board based on comments from board.
 - Commissioner Richards recommended that the ordinance be reviewed, and any changes made with a timeline in place

Motion Ager, Second Herman to send back to planning for further discussion during the Planning board and bring back to commission second meeting in February. Vote Unanimous. Motion Carried

Mark Hespe – Representatives from Butte County Volunteer Fire Departments were present to discuss plan and need for forming of new fire department (Butte Fire Department). The department will serve the northern part of Butte County. Hespe requested approval from Commissioners to submit to state as part of process.

Motion Herman, Second Walton to offer support of forming new fire department Butte Volunteer Fire Department. Vote Unanimous. Motion Carried. Roster will be provided to Auditor Capp when available.

Mike Grubl of Vale also discussed the need for PPE, radios, and other upcoming funding needs. Many of the volunteers are using personal finances to fund needs. They asked that funds allocated end of year be specifically distributed for needed equipment.

Sheriff Lamphere presented the Courtroom Security award Letter to Auditor Capp. Pay up front and get reimbursed for 75% of cost. Options were discussed on where trials would be held during courthouse closures.

Sheriff Lamphere gave an update on the Courthouse HVAC system. During the Dec 06th regular meeting options will be provided to commissioners. Auditor Capp asked if the Admin building could be included in the options/quotes.

Sheriff Lamphere asked if there was a decision made on Active Shooter Response Equipment – none as of now. Training may provide more guidance on necessities.

State's Attorney LeEllen McCartney presented the State's Attorney office activity report including 148 cases currently scheduled thru the end of 2022. Many may be settled prior to date. Continuing to work on clearing dockets, upcoming trials, felony docket cases, and recently sentenced case. Looking at a way to provide stats on types of cases for future reporting using current system. Over \$13,000 received as part of JJRI program. Newell's truancy program is successful and fully supported by school.

Auditor Capp presented an activity report including 2022 General Election status, Levies, retirement event for Kathy Nov 30, 11:30 – 1:30, Local Assistance and Tribal Consistency Fund 2022 distribution \$ 256,246.37, lights in front of Admin building, Commissioner Handbooks, and Commissioner Orientation.
