THE BOARD OF BUTTE COUNTY COMMISSIONERS CONVENED AT 6:00 P.M. on March 7th, 2023. The meeting was recorded. Commissioner's present were Harms, Ager, Walton, Herman, and Erk.

Motion by Walton Second by Erk to approve the meeting agenda with additions of GIS MOA between City of Belle Fourche/Butte County and contract for housing of prisoners and detainees in the Meade county jail under New Business and removal of Keynen Merrell. Vote Unanimous. Motion Carried.

Motion by Walton Second by Herman to approve minutes of 21February2023 Regular Meeting Minutes with no changes. Vote Unanimous. Motion Carried.

Motion by Ager Second by Herman to approve the Bills for Payment as presented by Auditor Annie Capp. Vote Unanimous. Motion Carried. Approval Sheet signed by all Commissioners and Auditor.

Motion by Erk Second by Herman to approve payment of Apportioning and Other payments per Printout as presented by Auditor Annie Capp with no changes. Vote Unanimous. Motion Carried. Approval Sheet signed by all Commissioners.

There were no Travel Requests or Abatements

State's Attorney LeEllen McCartney presented the activity report with comparison between types of cases/court appearances in Jan and Feb, grand jury, current cases, number of inmates currently in jail, and intern offer of employment.

State's Attorney LeEllen McCartney led a discussion regarding Northern Hills Sexual Assault Response Team (SART) and MOU. Group is attempting to reinvigorate team for sexual assault victim resources/services with a new MOU that has been signed by SA office.

Beginning at **6:15 P.M.** an opportunity for Public Comment was opened.

- Sue Broadhurst shared her research of commission minutes on certain topics and lack
 of information she has been able to find in minutes. Topics mentioned were sale of
 property by County and purchase of County Administration Building. Also mentioned
 were cell phones and lack of record of votes.
- Calvin Fickbohm wished to mention the cattle guard policy and the four cattle guards on Riley Road, the condition of guards and how they affect emergency responders.
- Katie Hoffmann wanted to point out the lack of consistency with votes, comments, and actions (used Commissioner Ager's votes on Cannabis ordinance as an example).
- Dale Simanton stated he was at the last meeting during the Planning Board Commissioner Appointment. Mr. Simanton was disappointed in the process and expressed his concern with Commissioner Ager in particular.

Beginning at **6:30 P.M.** a Public Hearing was held to Open Bids – Articulated Concrete Mattress (Highway Department).

• Fuel - MG Oil for Unleaded, Diesel 1 and 2 – bid on margin due to fluctuation, Unleaded \$.428, #2 Diesel \$.127, #1 Diesel \$.127. Changes will be communicated.

Highway Administrator Lori Johnston presented an activity report including snow removal, signs repaired, Superintendent Heidrich went to Western South Dakota Highway Superintendent Conference previous week and was able to meet four new superintendents.

Motion by Walton Second by Ager to approve the Application for Occupancy on the Right of Way of County Highways...BHE converting overhead powerline to underground Garness & Palo Rd (west of Ed Baker). Vote Unanimous. Motion Carried.

Motion by Ager Second by Erk to approve the Application for Occupancy on the Right of Way of County Highways-Dale Sprague-Wilson Cemetery & Gammon Rd trenching for irrigation water line. Vote Unanimous. Motion Carried.

Discussion was held regarding the 2024 Weed & Pest Conference to be held in Spearfish. W&P Board requested rooms during the event (three evenings) even though the distance does not meet the requirements. Motion Erk, Second Herman to deny the request for three rooms during the 2024 Weed & Pest Conference. Vote Unanimous. Motion Carried.

Discussion was held regarding the Sheriff's pickups to be transferred to Hwy Dept. Neither department has budgeted for these repairs.

Motion Walton, Second by Herman that the Sheriff and Highway Department split the cost of pickup repair. Vote Unanimous. Motion Carried.

Highway Administrator Lori Johnston mentioned that cattle guards are being inspected on Riley Road, one will be replaced, one will be pulled.

Motion Walton by Second by Ager to approve Final Plat - Owner: Doug Eichler- Lot 1 of Eichler Subdivision located in S2SW4 of Section 9 T8NR6E, B.H.M. Butte County, South Dakota. Vote Unanimous. Motion Carried.

Auditor Capp presented an activity report including correspondence, legislative bills activities in Pierre, updates on collection of liens, and Wells Fargo account - a resolution for the cancellation of checks and warrants two (2) years or more will be done in June to close account out.
