Beginning at 9:41 AM an opportunity for Public Comment was opened.

- Sue Broadhurst: Ms. Broadhurst explained the count of fifteen cannabis applications that received initial certificate of compliance (15) and the difference of what was approved for Permits to Operate (10) and 2023 renewals (10). Ms. Broadhurst spoke on the initial and first draft of the cannabis ordinance, stating that these were done prior to administrative rules being implemented by the State, further suggesting Commissioners "jumped the gun" by six months. Ms. Broadhurst also said the minutes did not reflect the motions made and reasons for the motions causing confusion.
- Dale Simanton: Mr. Simanton has been to several meetings with various complaints. Mr. Simanton gave some history of reasons to speak in previous meetings and long time to get results with previous Highway personnel. Mr. Simanton then said there was a recent issue with a pipe and said that by the time he went home Highway Superintendent Heidrich was already there looking at the problem.
- Travis Ismay Mr. Ismay said that the audio for the meetings is not up to par and requested a microphone be placed at the table to mitigate the poor audio.

Highway Supervisor Dwayne Heidrich presented an activity report including snow removal, repaired a guard rail repaired and fixing a lot of signs. There has been a lot of recent damage (run over and shot) on signs recently. Lori Johnston and Dwayne Heidrich attended the Weed and Pest conference last week.

Motion by Walton, Second by Erk to approve Highway Employee – Remote Contact Policy. Vote Unanimous. Motion Carried. More research will be done on available dashcams and potential grants available.

Additional discussion was held regarding the sign damage. Potentially the Sheriff's office can do additional patrols and public observation. The roads with most sign damage are 3V, Rehorst, and Sourdough.
