Beginning at 1:15 PM the following citizens appeared during the Public Comment Session:

- Fire Chief Aaron Thramer
   – shared his concerns on potential water availability for future
   development in area, as far as fire suppression. Closest water is at Big D and would
   need to have additional crews to shovel in water
- Duane Wilen of Wilen Enterprises commented about Sandstone Water Company past problems and mentioned he believed repairs have been made and state representatives working with water companies.
- County is in contact with DANR to potentially have a community presentation

Ken Barker of High Plains Cannabis addressed the commission on a request to change address from original application approved by Commission and State. Received approval from County and State for original location and if they move to location with existing building, must begin process over under revised ordinance effective 06Aug2022.

Rick McCartney spoke to commissioners about concerns with water, his discussions with Mayor Schmidt, potential issues, the process for approval, and potential solutions regarding compliance with and/or changes to existing ordinances.

County is exploring options, reaching out to state resources, and educating themselves on existing ordinances and how to regulate developments.

Mike Grubl Vale Fire Chief Fire spoke on upcoming requirements for mobile and portable radios and the funding that will be required. Grants are being reviewed currently; some additional funds will be required. Emergency manager Fred Lamphere added County will determine need for all fire departments and prioritize. Prices are going down and more opportunity may be available for grants due to disaster declaration.

Special meeting held 15Aug – planning to form a new State certified fire district. Will be on future agenda for commission approval.

Motion Harms, Second Walton to approve Final Plat as presented by Planning Director Donna Jones: Owner: Jack Johnson; Tract J; Located in SE4SE4 of Section 4, T8N, R5E, B.H.M., Butte County, South Dakota. Vote Unanimous. Motion Carried.
