THE BOARD OF EQUALIZATION CONVENED AT 9:30 AM. on April 11, 2024. Commissioners present were Herman, Walton, Erk, and Harms. Absent Ager. Also present were Director of Equalization Cristina Wilson, Field Assessor Johnna Ramirez, Field Assessor Stephanie Lippincot, and States Attorney LeElen McCartney.

Vice chair Herman called the meeting to order and led the group in the Pledge of Allegiance.

Motion Walton, Second Erk to approve the agenda as presented with no changes. Vote Unanimous. Motion Carried.

Members present took the County Board of Equalization Member Oath, notarized by Auditor Capp

Public Comments were called: none were present to speak for Board of Equalization items.

DOE Donna Jones presented findings to the County Board of Equalization.

- MCFARLAND, KENNETH E & KELLI J; 1449 BIRNAM WOOD LN; BELLE FOURCHE, SD 57717; Loss of Value due to Restricted Access
 - Matt Lucklum presented on behalf of Kenneth and Kelli McFarland. Homeowners believe the value of the home is half of what the assessed value assigned. The reason for the request for reduction is square footage loss and previously proposed plans for subdivision that have changed. It is presumed that current litigation regarding the property lines would affect the market value in current market. Additional documentation was provided to Board of Equalization by Mr. Lucklum.
 - Director of Equalization Cristina Wilson provided an explanation on the reasoning for value given to the property. DOE Wilson proposed removing value of the concrete lot and reducing the value of the driveway by 50% due to obsolescence. These suggested reductions were approved by Belle Fourche City Board of Equalization.
 - Mr. McFarland mentioned that for the amount of taxes he pays, this is small amount of lost revenue to the county. Mr. Farland believes that the lot lines (therefore value) are contingent on current litigation.
