Abatements: Abatement Request by Garet Hunt of CBH Co-Op tabled until 04Oct2022

Beginning at 6:15 PM the following citizens appeared during the Public Comment Session:

- Travis Ismay requested that the commissioners review the current cannabis ordinance section limiting the amount of cultivation facilities and read a letter by attorney David G. Evans.
- Deb Kukuchka stated her concerns with the amount of cannabis facilities approved in Butte County and shared some conversations she had with previous students on marijuana use in high school/s.
  - Commissioner Richards mentioned that the only place medical marijuana is at a permitted dispensary and Butte County must follow the ordinance in place.
- Michelle Evans shared her experience with her previous residence in Medford, Oregon, providing statistics and consequences of legalizing cannabis there. Ms. Evans also expressed concerns on consequences due to facilities – notably water.

Department of Legislative Audit Lead Auditor Bruce Hintz gave 2019-2020 Butte County legislative audit closing information including findings, required communications, internal control findings, and formal adjustments. No written findings were given, some oral recommendations were provided as well as adjustments to be made regarding classification changes only. Two areas of concern were outdated checks and use of Sourcewell for bidding. Report will be submitted and certified to Federal Audit Clearinghouse due to amount of Federal grants received during audit period.

Motion Walton second by Herman to authorize Chairperson Kim Richards to sign the Representation Letter. Vote Unanimous. Motion Carried.

Motion Harms, Second Walton to approve Final Plat as presented by Auditor Annie Capp: Owner: Johnson Family Trust; Tract A, A subdivision within the W2SW4; Located in Section 13, T9N, R6E, B.H.M., Butte County, South Dakota. Vote Unanimous. Motion Carried.

State's Attorney LeEllen McCartney presented the State's Attorney office activity report including felony and juvenile stats, grand jury status.

State's Attorney McCartney shared information on National Opioid Settlement. Motion Ager, Second by Herman to permit SA McCartney approval to apply for, update contact, and sign the Memorandum of Understanding. Vote Unanimous. Motion Carried.

SA McCartney provided update on State Cannabis Compliance Officer. State Department of health has hired Todd Leimser to fill the position. Plan for requirements and enforcement are being drafted to include training at state and local level. More information will follow.

State's Attorney McCartney provided information on the Notice of Non-Compliance for Black Hills Bud and status of compliance regarding obscure fencing.

Sheriff Lamphere presented quotes on panic alarms from Architectural Specialties LLC. Table decision until grant information is determined.

Sheriff Lamphere gave an update on radio assessment of all Fire Departments in the County. Suggested that any money allocated to fire departments at end of year be restricted to radio purchases. Grants for fire department and communications are available as well.
