Motion by Harms Second by Walton to approve the meeting agenda with no changes. Vote Unanimous. Motion Carried.

Motion by Herman Second by Walton to approved minutes of 19Apr2022 regular meeting with two corrections. Vote Unanimous. Motion Carried.

Approval of minutes of 05Apr2022 regular meeting postponed until 17May2022.

 - Deputy States Attorney LeEllen McCartney provided guidance based on SD codified law – "Minutes are to be summarized and listing of actions taken. Verbatim is only required for resolutions and ordinances.
 - o Travis Ismay suggested that commission meetings be videotaped and recorded
 - o Commissioner Ager recommended the minutes not be amended.
 - Commissioner Richards said it is a learning process for new auditor

Highway Superintendent Dwayne Heidrich presented an Activity Report including progress on grading, graveling, and bridge projects.

Motion by Herman Second by Harms to approve 2022 County pavement marking project. Vote Unanimous. Motion Carried.

James Sheeler requested that River Loop Rd be added back on County Hwy maintenance map.

Motion by Walton Second by Herman to River Loop Rd be added back on County Hwy
maintenance map as minimum maintenance. Vote Unanimous. Motion Carried.

Motion by Walton Second by Herman to surplus 1966 Rubber Tire Packer – not worth cost of repairing. Vote Unanimous. Motion Carried.

The States Attorney and Auditors office are reviewing the cannabis ordinance. Proposed revisions will be shared with commissioners.

A discussion was held regarding the voluntary withdrawal of a marijuana application and proposed return of portion of application fee. Deputy States Attorney LeEllen McCartney recommended the policy of a return minus 10% processing fee.

Motion by Ager Second by Herman to approve return of application fees minus 10% to Redwater Cannabis for applications voluntarily withdrawn. Vote Unanimous. Motion Carried.

State's Attorney, Cassie Wendt mentioned the Operational Certificate to be issued after County and State approval. These to be brought before Commission for approval then \$10,000 fee is due.

- Commissioner Ager asked if Commission could remove a license if concerns are brought to them after approval
